3RD MEETING OF

AIPA ADVISORY COUNCIL ON DANGEROUS DRUGS (AIPACODD)



The AIPA Secretary-General attended the 3rd Meeting of AIPA Advisory Council on Dangerous and Drugs (AIPACODD) via videoconference on 29 June 2020 from 08:30 am to 12:30 pm (GMT+7).

The meeting focused on the country progress report of all ten (10) AIPA Member Parliaments and discussion on the proposed draft resolution on "Turning words into Actions towards a Drug-Free ASEAN Community".

The full report of the 3rd AIPACODD Meeting will be submitted for consideration and adoption of the Committee on Social Matters of the 40th AIPA General Assembly.

AIPA CAUCUS MEETING

The 11th AIPA Caucus Meeting was convened virtually on 14 August 2020 by the House of Representatives of the Philippines. The meeting presented country reports on the implementation status of the resolutions adopted at the 40th AIPA General Assembly in 2019.

In addition to the country reports, the 11th AIPA Caucus Meeting also discussed the Working Group topic "Mitigating Risks and Economic Resilience in the Period of Pandemic". A representative from ASEAN Secretariat delivered the

Regional Report on the actions and response of ASEAN in the connection to the Working Group topic. The full report of the 11th AIPA Caucus Meeting will be tabled for consideration and adoption of the Committee of Political Matters of the 41st AIPA General Assembly.

For the next host of the AIPA Caucus, AIPA Secretariat received an email from the Parliament of Singapore, confirming that Singapore will be the host of the 12th AIPA Caucus Meeting in 2021. Further details and documents regarding this matter will be provided by the Parliament of Singapore.





ASEAN-AIPA INTERFACE MEETING

The ASEAN Leaders' Interface with Representatives of the ASEAN Inter-Parliamentary Assembly (AIPA) at the ASEAN 36th Summit was held via videoconferencing on 26 June 2020 chaired by Viet Nam.

The ASEAN Leaders' Interface was attended by Heads of State/Government of the ASEAN Member States, President of AIPA, Speakers/Deputy Speakers/Heads of Delegation of the 10 AIPA Member Parliaments, Secretary-General of ASEAN and Secretary-General of AIPA.

AIPA President delivered a Message at the ASEAN-AIPA Interface Meeting which highlighted the AIPA's supports to the Declaration of the Special ASEAN Summit on COVID-19 and various ASEAN meetings in response to the COVID-19 pandemic. AIPA Message also brought the attention of ASEAN Leaders to certain regional issues in terms of political-security, economy, and socio-cultural.

event was held on 30 July 2020 and attended by AIPA Member Parliaments, IPU, UN, UNESCO, World Bank, as well as the Vietnam government's representatives and diplomatic corps. The fruitful meeting has resulted a Draft Resolution that is aimed to be adopted in the 41st GA.

With an aim to promote parliamentary role in the domain of education and culture with links to the implementation of Sustainable Development Goals (SDGs), this event also demonstrated collateral responsibilities between AIPA and IPU and among AIPA Member Parliaments in assessing SDGs implementation in each member country. Amidst the complicated evolvement of COVID-19 pandemic in the

region and in the world, causing serious consequences on a global scale, more than ever, countries need to unite and join hands to promote the implementation of Sustainable Development Goals in which cooperation in education and culture adapting to the new context plays an important role.

The ECC Conference is a forum for the AIPA Member Parliaments, international organizations and the IPU Secretariat to discuss, share experiences and initiatives to foster cooperation and make contributions to the common efforts to achieve the sustainable development goals in the new context.

DIRECTORATE

POLICY, EDUCATION AND PUBLICITY

Directorate of Policy, Education, and Publicity (PEP) is committed to serving AIPA in its internal and external relations. Aiming at informing Member Parliaments of the current and forthcoming activities. the Directorate maintains good communication with the National Secretariats regularly. To smooth the communication between AIPA Secretariat and National Secretariats, as requested by the National Secretariats, a group-chat is created as an informal communication platform. Further, the Directorate of PEP also maintains good communication with the ASEAN Secretariat, MoU partners of AIPA, as well as Member Observers.

Divided into two sub-divisions; Education and Publicity, the Directorate provides insight and analysis to Secretary-General and AIPA Member Parliaments on matters of AIPA's concerns, including SDGs, drug menace, wildlife, child protection, capacity development, and ASEAN integration.

Further, the Directorate of PEP also has been innovatively developing an educational program, not only for community outreach purposes but also to develop the capacity of the AIPA Secretariat staff. Education is important to disseminate information on how AIPA works and its role within the process of ASEAN integration. Hence, AIPA has been implementing several educative and awareness-raising programs.


ATTACHMENT **PROGRAM**

Attachment Program is an awareness program in which AIPA Secretariat recruits students and/or fresh-graduates from various universities in Indonesia as well as overseas graduates. The program was first implemented in 2014, and since then has been receiving a lot of interest from young people. if previously the placement of participants in the attachment program was only under the Directorate of Policy, Education and Publicity, since 2018 AIPA Secretariat has been giving options to the applicants to be placed in other Directorates, such as; Directorate of Information, Communication and Technology, and Directorate of Finance and Administration.

AIPA Secretariat received 149 applicants from 2019 to 2020. This number is slightly lower compared to the last period number of applicants with 168 applicants due to the current global health issue caused by the COVID-19 pandemic. From 149 applicants, AIPA Secretariat has recruited 6 applicants to be assigned under two directorates; PEP Directorate and ICT Directorate. The interns are given the opportunities to have a hands-on experience to AIPA's and AIPA Secretariat's works.

There is significant increase in the number of applicants from 2016 to 2019. If from October 2016 to September 2018 AIPA Secretariat only received 39 applicants, throughout October 2018 to August 2019 we have received 168 applicants from all over ASEAN.

From the 168 applicants, AIPA Secretariat has recruited four fresh-graduates and three under-graduate students, who were assigned in the three Directorates. The interns are given the opportunities to have a hands-on experience to AIPA's and AIPA Secretariat's works.



Though the program receives a lot of interest from young people all over ASEAN, the recruitment of this program, however, is limited to Indonesian candidates. This happens due to the obscurity in the type of visa required to participate in an internship program

in Indonesia. Communication with the Indonesian Immigration Office and Ministry of Foreign Affairs continues, so that AIPA Secretariat could recruit students and or fresh-graduates from outside Indonesia.



MODEL AIPA 2019



Model AIPA was founded in August 2017 to introduce AIPA and its important role in ASEAN to youth in ASEAN countries. It is an educational simulation of the AIPA General Assembly for students. In this program, students will learn about parliamentary diplomacy, decision-making, and drafting AIPA resolutions.

AIPA Secretariat, in cooperation with BINUS University and University of Al-Azhar Indonesia International Relations Students Association, successfully convened the 3rd Model AIPA in September 2019, with the theme of "Towards a Peaceful, Stable, Secure and Prosperous ASEAN" at DPR RI Compound, Jakarta, Indonesia. Three topics were discussed under three different committees; Political Committee, Economic Committee, and Social Committee.

70 university students from eight countries (Cambodia, Indonesia, Malaysia, Philippines, Thailand, Vietnam, India, and Bangladesh.) participated as delegates representing each AIPA Member Parliament. Scholarships were provided to the selected delegates which covered their accommodation, meals, and transportation during the program.

PARLIAMENT **VISIT**

Parliament Visit was established to provide a better understanding and knowledge of the political system and parliamentary diplomacy. Using its network, AIPA Secretariat provides service in arranging visits of students to AIPA Member Parliaments. The visit is not limited to be conducted in the Indonesian Parliament, but could also be conducted in other AIPA Member Parliaments.

In December 2019, more than 100 students from BINUS University in Jakarta visited the Indonesian Parliament. The visit presented two topics of the political system of the Indonesian Parliament, presented by the representative from the Indonesian Parliament, and the introduction of the works of AIPA was presented by the representatives of the AIPA Secretariat. The parliament visit program was cohosted by the House of Representatives of Indonesia.



CAPACITY DEVELOPMENT FOR AIPA SECRETARIAT STAFF

This program is a part of the scope of cooperation between AIPA and the Federal Republic of Germany through the AIPA4ASEAN Integration Project. Under this project, GIZ as the implementor agency and its consultants conducted several individual competency assessments as the measurement to see the kind of capacity development activities and training/courses required by staff. The Directorate of the PEP coordinated with the GIZ to assist in proposing pieces of training to ensure that

the activities will impact positively on the daily work of the staff.

The highlights of this period capacity development activities are: English Course Program of eight AIPA Secretariat Staff which has ended in September 2019, Training in Writing AIPA Resolutions which was participated by the Deputy Secretary-General and three staff, and workshop on Strategic Plan and Resource Mobilization attended by all of AIPA Secretariat staff.

AIPA Secretariat has been engaging actively with other partners to conduct a joint seminar and to submit project proposals to potential donors. This year, AIPA Secretariat has been in contact with the UK Mission to ASEAN for future potential financial assistance proposals and potential collaboration projects with AIPA Partners and international organizations such as UN, PSALW (Parliamentary Forum on Small Arms and Light Weapons) and ICCF

(International Conservation Caucus Foundation).

As the position of the Director of Committee and Director of PEP are vacant, some adjustment within the AIPA Secretariat team has been made. Currently, six-person (AIPA Secretary-General, Deputy Secretary-General, Secretary to Secretary-General Education Officer, Publicity Officer, and Communication Officer) is working under the Substantives Team to provide service to the National Parliaments and Secretariats in preparing and executing AIPA regular annual meetings and outside projects.

In the topic of wildlife, AIPA is partnered with Freeland, and the partnership was first established in 2012, following the adoption of the resolution on "Strengthening Law Enforcement and Regional Cooperation to Combat Wildlife Crime and on Partnership with ASEAN/WEN / ARREST Program / Freeland Foundation".

The MoU with Freeland was renewed on 23rd July 2019 for another three-year phase up until 7th December 2021.

The parties agreed to implement activities that shall include, but not necessarily limited to:

a.Research. Policy/Legislation Development, and Review

b. Communication **Public** and **Awareness**

The draft resolution of this MoU will be tabled at this year's 41st AIPA General Assembly after postponement last year due to the

MoU was signed long after the deadline submission of the draft resolution at 2019 AIPA General Assembly in Thailand.

AIPA and Freeland jointly conducted a Web-based seminar (Webinar) on "Wildlife Trade and Links with COVID-19 and other Zoonotic Outbreaks" to provide briefing information for parliamentary staff in relation to law enforcement, environment, and public health concerning COVID-19. Parliamentary staff from eight countries (Brunei Darussalam, Indonesia, Lao PDR, Malaysia, Myanmar, the Philippines, Singapore, Thailand, Viet Nam), and AIPA Secretariat participated in the webinar.

AIPA - ERIA ONLINE JOINT DIALOGUE ON

Under the new leadership of the new AIPA Secretary-General, AIPA Secretariat and ERIA arranged a meeting between AIPA Secretary-General on 30 September 2019 and the ERIA President on 14 November 2019. The meeting was focused on the discussion on the renewal of Memorandum of Understanding and cooperation between two parties.

AIPA ERIA and renewed their Memorandum of Understanding for another three-year phase to support the progress of ASEAN Economic Integration. The signing ceremony was conducted on 22 January 2020 and was witnessed by the ASEAN Secretary-General and Japanese Ambassador to ASEAN at the ASEAN Secretariat building in Jakarta. The draft resolution will be tabled and discussed at the 41st AIPA General Assembly.

Following the resolution on "Establishing AIPA-ERIA **Joint** Dialogue to Support the Waste Management for Sustainable Development" adopted at the 40th AIPA General Assembly, AIPA and ERIA jointly convened virtual Joint Dialogue on Waste Management on 13 July 2020.

The ioint dialogue successfully gathered 54 participants, in which consists of AIPA Members Parliament and parliamentary staff from nine countries (Brunei Darussalam. Indonesia, Cambodia, Lao Malaysia, Myanmar, the Philippines, Thailand. and Viet Nam). **AIPA** Secretariat, ERIA, and experts to discuss waste management system in ASEAN in the midst of the COVID-19 pandemic.

PARLIAMENTARY INSTITUTE OF

CAMBODIA (PIC)



AIPA and PIC share the common objective to create learning opportunities of the national parliaments of ASEAN Member States in exchanging the knowledge, best practices, ideas, and experiences on capacity development among the respective parliaments, which will contribute to the strengthening of legislative capacity in ASEAN.

The two-phase of training seminar entitled "An Overview of Parliamentary Responsibilities: Strengthening the Institution" targets the parliamentary staff of AIPA Member Parliaments, to enhance knowledge and understanding of diverse parliaments and specific aspects of parliamentary responsibilities to promote interaction and exchanges between parliaments.

Around 42 participants joined the first module of the training seminar on 7 -11 October 2019 in Siem Reap, Cambodia, in which consist of parliamentary staff at director level from nine ASEAN Member States (Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, the

Philippines, Thailand, and Viet Nam) and staff from AIPA Secretariat. The second module was initially scheduled from 17 to 21 February 2020 in Siem Reap. Cambodia. However. the seminar was postponed due to worldwide concern and travel restrictions caused bv the COVID-19 pandemic. The second module is changed to be conducted through online delivery and rescheduled from 5


October to 6 November 2020.

Another program conducted the PIC this year is the Regional Fellowship Program on Parliamentary Diplomacy (RFPPD). This program aims to strengthen the capacity of parliamentary staff to better support their parliaments to engage in Parliamentary diplomacy. The first intake of RFPPD has been concluded in the fourth week of November 2019 with a total of 12 fellows from five countries (Cambodia, Malaysia, Myanmar, the Philippines, Thailand) participated in the program. The second intake was originally planned to be held from 16 March 2020 to 10 April 2020. PIC has adjusted its method to conduct the simulation workshop virtually and the schedule from 20 April to 11 September 2020.

INITIAL PARTNERSHIP

ASEAN INTER-PARLIAMENTARY ASSEMBLY (AIPA)

& INTERNATIONAL CONSERVATION CAUCUS FOUNDATION (ICCF)



On 19 June 2020, the first virtual briefing programs between AIPA and International Conservation Caucus Foundation (ICCF) titled "On the Origins of COVID-19, preventing Future Pandemics, and the Wildlife Trade" was conducted to facilitate the discussion between experts and AIPA member parliaments and to examine between the policymakers the steps that they could take to prevent future pandemics. The webinar was participated by at least 8 AIPA member parliaments (Brunei, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Thailand and Vietnam).

The ICCF works to build political will through the establishment and development of legislative caucuses centered around issues of conservation

This parliamentary governance. caucus model, first pioneered in the U.S. Congress and now being replicated in parliaments in Africa, Latin America, and Asia. The ICCF is working at the highest levels of governments and in a wide range of issues in developing countries around globe, including combating wildlife trafficking, building institutional capacity of national parks systems, and ensuring the sustainability of ocean resources.

Acknowledging the role of AIPA is in line with ICCF, in which one of AIPA's aims is 'to study, discuss and suggest solutions to problems of common interest and express its views on such issues with the aim of bringing about action and timely response by the members of AIPA'.

the objectives of the initial collaboration are; 1) to define national conservation priorities which related to the current situation following the outbreak of the COVID-19 in AMS, and 2) to deliver the solutions to member parliaments (MPs) in strengthening the AMS laws/regulations/ policies regarding the mentioned topic.

The initial joint program is expected to open the opportunity for ICCF and AIPA to further engage each other in cooperation to policymaker programs and dialogues which in protocol is officially marked by the signing of the Memorandum of Understanding (MoU) between two organizations.


AIPA **FACEBOOK**

As of July 30th, 2020, the number of followers of the AIPA Facebook page reached around 10,123 followers from the 7,159 followers last year, showed the increased by 28% compared to last year. In a year, the Facebook posts had reached the total number of 1.45 M Post Impressions, 29.9K Reactions, 81.2K Engaged Users, 771 Link Clicks, 1.02M Post Reach. Based on the report result given by Buffer, the platform had 312 daily average engagement, 3,664 daily average impressions, and 2 daily average clicks.

The highest reach this year is a post with the title "Internet Speed in ASEAN Countries" accounted for a total of 9.5K People Reached, 66 Reactions, 367.2K Impressions, 1,2 K engagement, and 48 Shares.

Gender variations were generally significant. The third quarter of the audiences (people reached and followers) were male (63) compared to females (37%). Similar with the last year's statistic for the origin of the followers, Myanmar is still the biggest percentage of the audiences (30%) followed by Cambodia (16%) and Indonesia (15%) (See Figure 2). Based on the age distribution,

audiences were grouped into three age brackets; Young Adults (18-24 years old), Middle-Aged (35-54 years old), and Senior Citizens (55 or over). The significant difference of the statistic compared to last year laid on the ratio of followers, with Middle-Aged followers surpassed the numbers of Young Adults. This year, Young adults represented 39% of the total followers, 56% Middle-Aged people, and 56% senior citizens (see Figure 3).



AIPA INSTAGRAM

The followers of the Instagram page of AIPA were steadily increased. The number of followers in July 2019 is 2,221 and reached 3,344 in July 2020. Moreover, the performance statistic shows a good overall result with the total Impression of 142.1K and 70.2K Reach.

The demographic information compared to last year showed similar Examining the shares of gender, this year AIPA Instagram account has more female users (53%) compared to male users (47%). A total number of followers were 2% teenager (13-17 years old), 85% were young people (18-34 years old), 11.7% were middle-aged people (35-54 years old), and 2% were senior citizens age 55 or over. The followers of Instagram came from Indonesia (73%), followed by Malaysia (4%), Brunei (3%), Thailand (2%) and Philippines (2%).


AIPA **WEBSITE**

New Layout Website






DESIGN & VIDEO

VIRTUAL **MEETING**

Amidst the COVID-19 pandemic, AIPA Secretariat officers are obliged to work from home. This condition affects the meeting process of AIPA. Most activities are conducted virtually and following this factor, the ICT Directorate has occasionally assisted to prepare and to maintain the technical function for the seamless process of the virtual meetings. Moreover, from June to August approx. ten virtual meetings have been conducted or hosted by AIPA Secretariat. The ICT team is working from home or office and the house of the Secretary-General of AIPA to organize, arrangements the virtual meeting process which is often held because of the pandemic conditions.


