### 6th World Forum on Intercultural Dialogue





Upon the invitation from the Government of the Republic of Azerbaijan, the AIPA Secretariat attended the 6th World Forum on Intercultural Dialogue from 1-2 May 2024 in Baku, Azerbaijan. Under the theme of "Dialogue for Peace

and Global Security: Cooperation and Interconnectivity," the forum aimed to foster intercultural dialogue and cooperation to address global challenges. In the margins of this forum, an inter-parliamentary conference on the Role and Best Practices of the Legislature in the Protection of Cultural Heritage was organized by the Milli Majelis of Azerbaijan. Two AIPA Member Parliaments; Malaysia and the Philippines, participated in the event. The conference highlighted the great significance of the legislative processes in safeguarding cultural heritage and represented a platform for exchanging useful ideas on parliamentary cooperation.





On the sidelines of the two events in Baku, the AIPA Secretary General had courtesy meetings with high ranking officials of Azerbaijan. The AIPA Secretary General had the opportunity to engage with H.E. Sahiba Gafarova, the Speaker of the Milli Majlis of the Republic of Azerbaijan, H.E. While the coordination meeting focused on discussing regional terrorism trends and reviewing Counter-Terrorism/Preventing Violent Extremism (CT/PVE) initiatives addressing associated challenges, the parliamentary policy dialogue focused on enhancing defenses against increasing terrorist threats to religious locations and symbols. In this regard, the AIPA Secretary General took the opportunity to share AIPA's collective endeavor in countering terrorism and violent extremism and its contribution to the implementation of Bali Work Plan 2019-2025.

AIPA Secretariat participated in the 16th Coordinating Conference for the ASEAN Political Security Community (APSC) on 7 May 2024 in ASEAN Headquarters, Jakarta. ## Stakeholders Roundtable on Advancing Women Political Participation and Leadership in ASEAN



The AIPA Secretariat and UN Women jointly organized a Roundtable Discussion on Enhancing Women's Political Participation and Leadership (WPPL) in ASEAN, titled "Promoting Gender-Responsive Parliaments for a Resilient, Connected, and Inclusive ASEAN Community," on 30 May 2024 at Grand Mahakam Hotel, Jakarta. The event convened over 20 high-level representatives from ASEAN member states and key dialogue partners, including Permanent Representatives of ASEAN Member States and Heads of Diplomatic Missions to ASEAN.



The event provided a platform to explore potential opportunities and partnerships aimed at supporting the implementation of the WPPL Plan of Action and Implementation Framework, developed by Women Parliamentarians of AIPA (WAIPA), to strengthen women's leadership and political participation across ASEAN. Fostering partnerships at this stage is pivotal to ensure effective implementation of these strategic documents

following their anticipated adoption at the upcoming 45th AIPA General Assembly.

## The 6th Intake of the PCAsia Programme on Parliamentary Diplomacy (PCAsia-PPD)



Started in May 2024. the Parliamentary Centre of Asia (PCAsia), AIPA's MoU partner, conducts its 6th intake Programme on Parliamentary Diplomacy (PCAsia-PPD) in a hybrid format. This program, attended by parliamentary staff from AIPA Member Parliaments, aims to enhance their capacity to effectively support parliamentary diplomacy efforts.

During a session on 30 May 2024, the AIPA Secretariat provided insights into parliamentary diplomacy practices from the perspective of AIPA and the Secretariat. This session facilitated a valuable exchange of knowledge and fostered deeper understanding between the AIPA Secretariat and the participating parliamentary staff regarding the practice of parliamentary diplomacy at the regional level. This programme is part of AIPA's cooperation with PCAsia and ran from May to July 2024.
