DECEMBER HIGHLIGHTS

ASEAN RAI Parliamentary Implementation Framework 2024-2030: Transformative Collaboration for ASEAN's Sustainable Future



Building on the adoption of the ASEAN-RA Parliamentary Implementation Framework at the 45th General Assembly, the **ASEAN** Parliamentary Assembly (AIPA), in partnership with the Food and Agriculture Organization of the United Nations (FAO) and the International Institute for Sustainable Development (IISD), successfully hosted the 3rd AIPA-FAO-IISD Joint Event, "Championing **ASEAN** RAI: Parliamentary Leadership Partnerships for Responsible Investment in Food, Agriculture, and Forestry Sectors". The event took place on 12 December 2024 in a hybrid format, with in-person participation in Jakarta, Indonesia.





This milestone gathering brought together over 35 participants, including representatives from AIPA Member Parliaments, the diplomatic community, development partners, and the ASEAN Secretariat. It marked a pivotal moment for the implementation of the Framework, as pathfinder parliaments were identified to champion specific pillars and action lines. The event also opened new avenues for collaboration with relevant stakeholders, further strengthening efforts toward responsible investment in food, agriculture, and forestry across ASEAN.

H.E. Ambassador Sarah Al Bakri Devadason, Permanent Representative of Malaysia to ASEAN





Both parties reaffirmed their commitment to enhancing collaboration to ensure a sustainable and inclusive ASEAN Community.







As 2024 drew to a close, the AIPA Secretariat convened its 7th AIPA Roadshow on 9 December 2024 at the ASEAN Headquarters in Jakarta, Indonesia. With over 160 youths participating, the 7th AIPA Roadshow fostered greater awareness of AIPA's role in advancing regional cooperation through parliamentary diplomacy.

Beyond raising awareness, the Roadshow provided a platform to engage youth on a regional scale through an Exclusive Dialogue Session. Featuring high-ranking officials and an inspiring youth representative from the region, the session offered participants a meaningful opportunity to engage with leaders and gain valuable insights into their vital role in shaping ASEAN's future.



AIPA's Engagement with Development Partners

6th Meeting of the Coordination Mechanisms for Parliamentary Assemblies



On 6 December 2024, the AIPA Secretariat virtually participated in the Sixth Meeting of the Coordination Mechanism for Parliamentary Assemblies on Counter-Terrorism, hosted by the United Nations Office of Counter-Terrorism (UNOCT). This meeting served as a critical platform for parliamentary assemblies to discuss regional

trends in terrorism and violent extremism, review initiatives implemented in collaboration with UNOCT, and address challenges faced in counter-terrorism (CT) and preventing violent extremism (PVE) efforts.

During the session, the AIPA Deputy Secretary-General delivered an intervention reaffirming AIPA's commitment to CT/PVE efforts. She highlighted the AIPA Strategic Plan 2023–2030, key resolutions, and both ongoing and planned initiatives. The intervention underscored AIPA's focus on strengthening legal frameworks and enhancing regional cooperation to effectively address terrorism and violent extremism in ASEAN.

Launch of the International Network for Legislation on Drugs (INLOD)

Upon the invitation of the United Nations Office on Drugs and Crime (UNODC), the AIPA Secretariat participated in the virtual launch of the International Network for Legislation on Drugs (INLOD) on 12 December 2024. INLOD seeks to establish a global network of legislators to enhance coordination, share knowledge, and address drug-related challenges through legislative collaboration and guidance.



During the event, the AIPA Secretariat highlighted the longstanding commitment of AIPA to addressing drugrelated issues, as reflected in 42 adopted AIPA resolutions. The Secretariat also emphasized AIPA's initiative to transition its Advisory Council on Dangerous Drugs (AIPACODD) into the AIPA Advisory Council on Transnational Crime (AIPA-ACT). This transformation broadens the scope of the ad-hoc council to include a wider range of transnational crimes, acknowledging the complex and interconnected nature of drug-related challenges within the region.

Meeting with the Security Cooperation Division I of the ASEAN Secretariat



Following the mandate from the Executive Committee of the 45th AIPA General Assembly, the AIPA Secretariat met with the Security Cooperation Division I of the ASEAN Secretariat on 12 December 2024 to discuss the AIPA's initiative to transform AIPA Advisory Council on Dangerous Drugs (AIPACODD) into the AIPA Advisory Council on Transnational Crime (AIPA-ACT). As a working-level meeting, it served to prepare for the upcoming official meeting between the

AIPA Secretary General and the ASEAN Deputy Secretary General for the ASEAN Political-Security Community scheduled for March 2025. The discussion provided valuable insights into ASEAN's mechanisms for addressing transnational crime, aiming to align parliamentary efforts with regional priorities and reaffirming AIPA's commitment to addressing the evolving challenges of transnational crime in the region.

Meeting with ERIA (Economic Research Institute for ASEAN and East Asia)

On 20 December 2024, representatives from the Economic Research Institute for ASEAN and East Asia (ERIA) and the AIPA Secretariat convened a meeting at the ERIA Annex Office in Jakarta, Indonesia. The meeting reflected on the success of the first Tripartite Forum held in Brunei Darussalam last year, with both organizations expressing gratitude for the fruitful collaboration. Discussions focused on exploring potential avenues for collaboration in 2025, building on the achievements of the Tripartite Forum and enhancing support for Malaysia's **AIPA** presidency. This meeting underscored the shared commitment of ERIA and AIPA to fostering stronger regional cooperation.



Launch and Award Session on "Parliamentary Approaches to the Use of Information and Communication Technologies in Counter-Terrorism in Accordance with UN Security Council Resolution 1373"



As part of its ongoing commitment to peace and security, AIPA Secretariat participated virtually in the Launch and Award Session on "Parliamentary Approaches to the Use of Information and Communication Technologies in Counter-Terrorism in Accordance with UN Security Council Resolution 1373" on 18 December 2024. Organised by UNOCT on the margin of Internet Governance Forum, the session provided a platform to discuss the

role of parliamentarians in addressing the use of information and communication technologies in countering terrorism.

Guided by the framework of UN Security Council Resolution 1373 (2001), the session emphasized the importance of national counter-terrorism measures that are holistic, inclusive, human rights-compliant, gender-sensitive, and effective. AIPA's participation reflects its commitment to supporting efforts aimed at enhancing security frameworks and counter-terrorism through parliamentary engagement.

Virtual Coordination Meeting between AIPA Secretariat and Secretariat of the Parliament of Malaysia



In preparation for Malaysia's AIPA Presidency for 2024-2025, the AIPA Secretariat and the National Secretariat of the Parliament of Malaysia held a virtual meeting on 20 December 2024. The discussion focused on planning AIPA activities throughout 2025, including ad-hoc and annual meetings under Malaysia's leadership. The meeting also provided an opportunity to explore further initiatives to be implemented during Malaysia's presidency, with an emphasis on fostering a more inclusive and sustainable ASEAN region.
